ORDER

The seniority list of Deputy Director upto the vacancy year 2010-11 was finalized vide Memorandum No. A-24/15/01/2016-E.I dated 30.07.2019. Subsequently, the seniority lists of Deputy Director for the vacancy years 2011-12, 2012-13 and 2013-14 were also finalized vide Memorandum No. A-24/15/01/2016-E.I dated 14.08.2020 followed by Memorandum of even No. dated 11.12.2020.

Thereafter, the Hon'ble CAT, PB, New Delhi, vide its judgement dated 12.07.2022 in O.A. No. 1545/2020 titled Praveen Kumar V/s ESIC & Ors., set aside the aforesaid three seniority lists of Deputy Director and, *inter-alia*, directed as under:

"We direct the respondents to issue a fresh seniority list for the post of Deputy Director strictly in accordance with the office memorandums issued by the DOP&T from time to time, specific guidelines/rules/memorandum which shall be applicable as on date, and strictly in accordance with the law as enshrined and as laid down by the Hon'ble Apex Court. The directions of the Tribunal be complied with within a period of 12 weeks from the date of this order."

In compliance of judgement/order dated 12.07.2022 of Hon'ble CAT, Principal Bench, New Delhi, the provisional gradation/seniority list of officers in the grade of Deputy Director in PB-3 Rs. 15,600-39,100/- with Gr. Pay Rs. 5400/- (Pre-revised) as on 01.01.2023 was issued vide Memorandum of even No. dated 14.02.2023 and errors and objections, if any, to this provisional seniority list were called for within 30 days from the date of issue of the said seniority list.

In response to the above circulation, 37 officers had filed their objections. These objections have been carefully examined in accordance with the aforesaid direction of Hon'ble CAT, PB, New Delhi read with extant instructions of DoP&T in the matter and Director General has ordered and disposed them off as under:-

No. 1545/2020, <i>inter-alia</i>, directed as under:</p> <p><i>"we direct the respondents to issue a fresh seniority list for the post of Deputy Director strictly in accordance with the office memorandums issued by the DoP&T from time to time, specific guidelines /rules /memorandum which shall be applicable as on date, and strictly in accordance with the law as enshrined and as laid down by the Hon'ble Apex Court."</i></p> <p>The provisions contained in OM No 20011/2/2019-Estt. (D) dated 13-08-2021 which has been issued by DoP&T, GoI, pursuant to the judgement of the Hon'ble Supreme Court of India in Civil Appeal No. 8833-8835 of 2019 of K. Meghachandra Singh & Ors. Vs Ningam Siro & Ors, are applicable as on date for fixation of seniority of direct recruits and promotees and their inter-se seniority .</p> <p>The provisions of Para 7 (i), (ii) (iii) and (iv) of aforesaid DoP&T O.M. dated 13.08.2021 are relevant for fixation of inter se seniority of such direct recruits and promotees who have been appointed before 19-11-2019. The provisions of the aforesaid Para 7 (i), (ii), (iii) and (iv) are as given below.</p> <p><i>"(i) DoPT's O.M. No. 20011/1/2012-Estt(D) dated 04.03.2014, issued in</i></p>

pursuance of Order dated 27.11.2012 in N.R. Parmar case, is treated as non-est/withdrawn w.e.f.19.11.2019.

(ii) As the Order dated 19.11.2019 is prospective, cases of inter se seniority of direct recruits and promotees, already decided in terms of O.M. No. 20011/1/2012-Estt.(D) dated 04.03.2014, shall not be disturbed, i.e. old cases are not to be reopened.

(iii) In case of direct recruits and promotees appointed/joined during the period between 27.11.2012 and 18.11.2019 and in which case inter se seniority could not be finalised by 18.11.2019, shall also be governed by the provisions of O.Ms. dated 7.2.1986/3.7.1986 read with OM dated 4.3.2014, unless where a different formulation/manner of determination of seniority has been decided by any Tribunal or Court.

(iv) For cases where the recruitment process has been initiated by the administrative Department / Cadre Authority before 19.11.2019 and where some appointments have been made before 19.11.2019 and remaining on or after 19.11.2019, the inter se seniority of direct recruits and promotees, shall also be governed by the provisions of OMs dated 7.2.1986/3.7.1986 read with OM dated 4.3.2014 to ensure equal treatment of such appointees"

The operative provisions for fixation of inter-se seniority as contained in para 5(a) to 5(i) of aforesaid OM dated 04-03-2014, is as under.

"

a) DoPT OM No. 20011/1/2006-Estt.(D) dated 3.3.2008 is treated as non-existent / withdrawn ab initio;

b) The rotation of quota based on the available direct recruits and promotees appointed against the vacancies of a Recruitment Year, as provided in DOPT O.M. dated 7.2.1986/3.07.1986, would continue to operate for determination of inter se seniority between direct recruits and promotees;

c) The available direct recruits and promotees, for assignment of inter se seniority, would refer to the direct recruits and promotees who are appointed against the vacancies of a Recruitment Year;

d) Recruitment Year would be the year of initiating the recruitment process against a vacancy year;

e)Initiation of recruitment process against a vacancy year would be the date of sending of requisition for filling up of vacancies to the recruiting agency in the case of direct recruits; in the case of promotees the date on which a proposal, complete in all respects, is sent to UPSC/Chairman-DPC for convening of DPC to fill up the vacancies through promotion would be the relevant date.

f) *The initiation of recruitment process for any of the modes viz. direct recruitment or promotion would be deemed to be the initiation of recruitment process for the other mode as well;*

g) *Carry forward of vacancies against direct recruitment or promotion quota would be determined from the appointments made against the first attempt for filling up of the vacancies for a Recruitment Year;*

h) *The above principles for determination of inter se seniority of direct recruits and promotees would be effective from 27.11.2012, the date of Supreme Court Judgment in Civil Appeal No. 7514-7515/2005 in the case of N.R. Parmar Vs. UOI & Ors.*

i) *The cases of seniority already settled with reference to the applicable interpretation of the term availability, as contained in DoPT O.M. dated 7.2.86/3.7.86 may not be reopened."*

In view of the facts mentioned above, it is very much clear that as per provisions of Para 7(iii) and 7(iv) of aforesaid OM dated 13-08-2021 read with provisions of Para 5(b) to 5(i) of aforesaid OM dated 04-03-2014, the principle of rotation of quota for fixation of inter se seniority of such direct recruits and promotees who have been appointed before 19-11-2019, is to be applied with reference to the year in which their recruitment was initiated / deemed to be initiated.

The applicant (Shri Praveen Kumar) was promoted to the post of Deputy Director on 24-07-2012 on regular basis against the vacancy year 2011-12. The proposal for promotion to the post of Deputy Director against which he was promoted, was sent to UPSC on 13.03.2012. The proposals for direct recruitment of such Deputy Directors who have been appointed after the concerned officer but have been placed above him, was sent to UPSC on 03.07.2008 (for vacancy year 2005-06 to 2008-09) and on 30.11.2010 (for vacancy year 2009-10 and 2010-11) i.e. **more than one year before** the proposal for promotion in respect of applicant, was sent to UPSC. Further the seniority list containing the name of Praveen Kumar was not finalized before 27-11-2012.

Accordingly, the inter-se seniority of Shri Praveen Kumar vis-a-vis the direct recruits who have been appointed after him, have to be fixed with reference to the year in which their recruitment was initiated / deemed to be initiated.

In view of the facts mentioned above, the Officer concerned has, rightly, been placed in the provisional seniority list of Deputy Director issued vide Memorandum dated 14.02.2023.

		<p>This does not amount to selective compliance of judgement dated 12.07.2022 of Hon'ble CAT, PB, New Delhi. Rather, it is in compliance of the order of Hon'ble Tribunal as in the instant case, the Hon'ble CAT, PB New Delhi, has not determined any different formulation / manner of determination of seniority list of Deputy Directors. Rather, it has only directed to issue a fresh seniority list for the post of Deputy Director strictly in accordance with the office memorandums issued by the DoP&T from time to time, specific guidelines / rules / memorandum which shall be applicable as on date, and strictly in accordance with the law as enshrined and as laid down by the Hon'ble Apex Court."</p>

As per old RRs, the method/mode of recruitment in the both cadres was 50% by direct recruitment and 50% by promotion.</p> <p>Accordingly, the direct recruitment (one mode) to fill up vacancies of Deputy Director (Finance) and Deputy Director (Administration / Training/ Insurance) of the vacancy year 2005-06 to 2010-11 were made through UPSC as per provisions of old RRs of Deputy Director (Finance) and Deputy Director (Administration / Training/ Insurance) which were notified on 07.02.1970 read with amendment dated 22.07.1995. However, the vacancies of promotion quota (another mode of recruitment) in the both cadre i.e. Deputy Director (Finance) and Deputy Director (Administration /</p>



Training / Insurance) for the vacancy year 2005-06 to 2010-11 was made through one RRs i.e. Deputy Director (Administration / Training / Insurance) and no separate panel by DPC in respect of Deputy Director (Finance) and Deputy Director (Administration / Training / Insurance) was recommended by DPC.

Due to non-availability of separate panel of Deputy Director (Finance) and Deputy Director (Administration / Training/ Insurance) in respect of promotees officers, it is not possible to draw a separate list of Deputy Director (Finance) and Deputy Director (Administration / Training / Insurance).

Further, the cadres of Deputy Director (Administration / Training / Insurance) and Deputy Director (Finance) are not in existence in ESIC as on date. As per existing RRs of Deputy Director notified on 06.06.2015, only one cadre i.e. Deputy Director is in existence in ESIC as on date. Accordingly, the said provisional seniority has been issued with designation of Deputy Director by applying rota-quota mentioned in the RRs i.e. 1:1.

As regards their prayer for re-drawing seniority list by applying principle of availability of officer in terms of DoP&T OM No. 35014/2/80-Estt. D dated 07-02-1986 and OM No. 22011/7/86-Estt (D) dated 03-07-1986 with respect to all officers who are available prior to 27-11-2012, it is stated that as per facts already explained in the reply to the representation of Sh. Praveen Kumar, the inter se seniority of direct recruits and promotees is to be fixed as per provisions of Para 7(iii) and 7(iv) of aforesaid OM dated 13-08-2021 of DoPT read with provisions of Para 5(b) to 5(i) of aforesaid OM dated 04-03-2014 of DoPT.

Thus, the principle of rotation of quota for fixation of inter se seniority of such direct recruits and promotees who have been appointed before 19-11-2019, is to be applied with reference to the year in which their recruitment was initiated / deemed to be initiated.

The applicants were promoted to the post of Deputy Director on 24-07-2012 on regular basis against the vacancy year 2011-12. The proposal for promotion to the post of Deputy Director against which they were promoted, was sent to UPSC on 13.03.2012. The proposals for direct recruitment of such Deputy Directors who have been appointed after the concerned officers but have been placed above him, was sent to UPSC on 03.07.2008 (for vacancy year 2005-06 to 2008-09) and on 30.11.2010 (for vacancy year 2009-10 and 2010-11) i.e. **more than one year before** the proposal for promotion in respect of the concerned officers/applicants was sent to UPSC. Further, the seniority list containing the name of the officers concerned was not finalized before 27-11-2012.

		<p>Accordingly, the inter-se seniority of the applicants vis-a-vis the direct recruits who have been appointed after them, have to be fixed with reference to the year in which their recruitment process was initiated / deemed to be initiated.</p> <p>In view of the facts mentioned above, the Officers concerned have, rightly, been placed in the provisional seniority list of Deputy Director issued vide Memorandum dated 14.02.2023.</p> <p>As regards their prayer for fixing their seniority above the officers indicated in para 3 (A) of their representation, the followings facts are noted:-</p> <p>Shri Sanjeev Mishra mentioned at Sl. No. 74 of the provisional seniority list was appointed through direct recruitment against the vacancy years 2005-06 to 2008-09 and the proposal for direct recruitment against these vacancy years was submitted to UPSC on 03.07.2008.</p> <p>The officers appointed through direct recruitment who are enlisted at Sl. No 112 to 216 alternatively in the provisional seniority list, have been recruited against the vacancy years 2009-10 and 2010-11 for which the proposal for recruitment, was submitted to UPSC on 30.11.2010.</p> <p>The proposal for promotion to the post of Deputy Director against which the applicants were promoted, was submitted to UPSC on 13.03.2012.</p> <p>As per provisions already explained above, the principle of rotation of quota for fixation of inter se seniority of such direct recruits and promotees who have been appointed before 19-11-2019, is to be applied with reference to the year in which their recruitment was initiated / deemed to be initiated.</p> <p>Accordingly, the direct recruits as referred by the applicants, have been placed above them.</p> <p>In view of above, the prayers of the concerned officers for changing their seniority position, are not acceded to.</p>


